#### PART I

#### STATEMENT OF FACTS

By Notice of Intention to Intervene dated July 11th,
 1985, the Attorney General of Ontario intervened in this appeal.

2. The Attorney General of Ontario makes no submissions as to the facts.

#### PART II

#### POINTS IN ISSUE

- 3. The points in issue in this appeal are set out in the constitutional questions stated by Dickson, D.J.C.:
  - (1) Does The Dairyworkers (Maintenance of Operations) Act, S.S. 1984, c. D-1.1, or any part thereof, infringe or deny freedom of association guaranteed in s. 2(d) of the Canadian Charter of Rights and Freedoms?
  - of Operations) Act, S.S. 1984,
    c. D-1.1, or any part thereof,
    infringe or deny freedom of association guaranteed in s. 2(d) of the Canadian Charter of Rights and
    Freedoms, is the Act, or such part, justified by s. 1 of the Canadian Charter of Rights and therefore not inconsistent with the Constitution Act, 1982?
- 4. The Attorney General of Ontario restricts his submissions to Question 1 and takes the position that Question 1 should be answered in the negative.

# PART III

## ARGUMENT

- 5. The Attorney General of Ontario respectfully adopts the argument on Question 1 in paragraphs 14 to 51 found in the Factum of the Attorney General of Saskatchewan.
- 6. The Attorney General of Ontario had made detailed submissions on the meaning and content of freedom of association in Charter section 2(d) in his Factum filed in Public Service Alliance of Canada v. Her Majesty the Queen in Right of Canada as represented by Treasury Board and The Attorney General of Canada, an appeal heard by this Honourable Court immediately preceding the appeal hearing in this case. The Attorney General of Ontario relies upon the submissions made in his Factum filed in the Public Service Alliance of Canada appeal.

#### PART IV

#### ORDER SOUGHT

7. The Attorney General of Ontario submits that the first constitutional question should be answered in the negative.
