ORDER FOR ATTENDANCE OF DETAINEE AT COURT PROCEEDING

TO the Minister of Public Safety and Emergency Preparedness of Niagara Detention Centre


UPON application in writing made this day by the said Applicant for an Order pursuant to the provisions of subsection 527(1) of the *Criminal Code*, requiring that RICARDO SCOTLAND, presently confined in the NIAGARA DETENTION CENTRE at ONTARIO, be brought before the presiding Judge of the SUPERIOR COURT OF ONTARIO at 361 UNIVERSITY AVE, TORONTO, Ontario, on the 10th of AUGUST, 2017, and from day to day thereafter as his attendance may be required in order that the said RICARDO SCOTLAND may attend and OBSERVE AND TESTIFY in accordance with the *Criminal Code*, subsection 527(1), and upon reading the said application dated this 1st day of AUGUST, 2017, and APPLICATION FOR HABEAS CORPUS, filed, and upon being satisfied that the ends of justice require that an order of the nature requested made;

IT IS ORDERED that the MINISTER OF PUBLIC SAFETY AND EMERGENCY PREPAREDNESS, of NIAGARA DETENTION CENTRE, in ONTARIO, deliver the said RICARDO SCOTLAND, presently an immigration detainee confined at that facility, to COURT SERVICES, SUPERIOR COURT OF ONTARIO (TORONTO), who shall receive the said prisoner from the said MINISTR OF PUBLIC SAFETY AND EMERGENCY PREPAREDNESS;

IT IS FURTHER ORDERED that the said COURT SERVICES, SUPERIOR COURT OF ONTARIO (TORONTO), in company with such other peace officers as he deems necessary, shall deliver the said RICARDO SCOTLAND on the 10th day of AUGUST, 2017 to be brought before the presiding Judge of the SUPERIOR COURT OF ONTARIO (TORONTO), for the purpose of THE HEARING OF HIS HABEAS CORPUS APPLICATION and to be thereafter dealt with in accordance with the order the Judge there presiding;

AND IT IS FURTHER ORDERED that the said RICARDO SCOTLAND be redelivered to the said NIAGARA DETENTION CENTRE by the said MINISTER OF PUBLIC SAFETY AND EMERGENCY PREPAREDNESS in company with such other officers as he (or she) deems necessary, at the completion of the proceedings for which his (or her) attendance is required unless the presiding Judge otherwise directs or he (or she) is otherwise dealt with according to law.
